This is a SOURCES SOUGHT NOTICE (not a pre-solicitation notice pursuant to FAR Part 5) to determine the capability of potential sources and the availability of commercial sources pursuant to FAR Part 10.

This notice is issued by the United States Coast Guard (USCG) Headquarters, Washington, DC to identify sources capable of providing insignia for the USCG Uniform Distribution Center (UDC).

The applicable NAICS Code is 313220 (Narrow Fabric Mills and Schiffli Machine Embroidery) with a size standard of 500 employees.

Any interested firm capable of providing these supplies is requested to respond via e-mail to: Unison Marketplace **no later than 12:00 p.m., 29 December 2022** with the following documentation:

- (1) Is your business a large or small business and how many employees?
- (2) If small, does your firm qualify as a small, emergent business, or a small, disadvantaged business?
- (3) If disadvantaged, specify under which disadvantaged group and is your firm certified under Section 8(a) of the Small Business Act?
- (4) Is your firm a certified hub zone firm?
- (5) Is your firm a woman-owned or operated business?
- (6) Is your firm a certified Service-Disabled Veteran-Owned?
- (7) Is your product listed on a GSA schedule?

(8) Do you have other government agencies using the product, and if so which agencies, POCs and contract numbers?
