# USCG UNIFORM PROGRAM CERTIFICATION BYLAWS FOR INSIGNIA AND RELATED ACCESSORIES

## I. PREFACE

The U.S. Coast Guard (USCG) established the Uniform Certification Program to certify a manufacturer's\* warranty that articles of uniform insignia sold to Coast Guard (CG) personnel by the Coast Guard Exchange System (CGES) or any other retail sales outlet meet or exceed prescribed standards of uniformity and quality for material, shade, design, construction, appearance, quality, workmanship, and durability. This program covers the authorized insignia and related accessories listed in enclosure (5) of this document.

\* A USCG certified insignia manufacturer is an individual, firm or corporation that has met Coast Guard Clothing Design and Technical Office (CDTO) certification requirements pursuant to these by-laws. Said manufacturer produces insignia or related accessories or both in their own plant, in cooperation with a subcontractor's plant or in any combination thereof, under the manufacturer's control, to the extent that the manufacturer assumes full responsibility and certifies that each item conforms to the requirements and quality provisions required by the USCG. Only those manufacturers of insignia and related accessories meeting the requirements expressed in these by-laws, will be issued certificates authorizing them to provide insignia or related accessories under this certification program.

## II. RESPONSIBILITY

### A. The Commandant

1. The Commandant of the U.S. Coast Guard is responsible for the implementation of the United States Coast Guard Uniform Program Certification policies.

### B. The Coast Guard Clothing Design and Technical Office Responsibility:

1. Establish the quality, standards, specifications and guidelines to assure uniformity of appearance and acceptable quality in articles of the uniform, insignia, and accessories.
2. Furnish, upon request by industry, copies of specifications, purchase descriptions, commercial item descriptions, stitch enlargements, standard samples, hubs, dies or other information pertinent to the insignia and related accessories listed herein (when available).
3. Provide manufacturers of insignia and related accessories guidance and information regarding changes in specifications, Coast Guard Regulations and the adoption of new items.

4. Invite manufacturers to submit representative samples of articles of insignia and related accessories to certify their conformity with appropriate standards and specifications.
5. Evaluate samples of insignia and related accessories submitted by manufactures to determine conformity with the item's specified requirements. Determine whether submitted items "meet or exceed" the United States Coast Guard's standards. Issue certificates that will authorize participating manufacturers to warrant by appropriate labeling that insignia and related accessories have been produced in accordance with applicable standards and specifications.\* These certificates will specify the insignia and related accessories, which the manufacturer is authorized to produce. The CDTO will furnish a list of certified manufacturers to USCG Headquarters and CGES.
6. Conduct visits to manufacturing sites, monitor certified items, review production methods and finished items. Inspect warehouses and stored stock. Perform random inspections of certified items taken from stock or submitted to the CDTO for evaluation.
7. Revoke or suspend certificates when it is determined that the certificate holder has violated any of the expressed conditions under which the certificate was issued. The minimum revocation period will be one year. Reinstatement of a manufacturer's certification may be made after the revocation period by product re-submittal. If the product is acceptable, a new certification number will be issued. Old certificate numbers will not be reissued.
8. Encourage insignia suppliers and manufacturers to participate in the certification process for the United States Coast Guard Uniform Program for Insignia and Related Accessories. Act as consultant to those seeking participation.

\* The Clothing Design and Technical Office retains the right to grant conditional certifications for all items. Conditional status is wholly at the discretion of CDTO. Conditional certification is assigned to allow the manufacturers to start production. Full certification will be granted once samples from production are received and approved by the CDTO.

### C. Individual Personnel

1. All personnel who wear uniform items purchased from commercial sources should be responsible for insuring that a certified manufacturer produced the items. USCG certified manufacturers shall incorporate a mark or label with the certificate number attesting that the item was produced in accordance with established requirements.

## D. Other Services' Items

1. Insignia and related accessories controlled and maintained by other services' specifications, and are certified by their respective Uniform Program and certification process will be considered accepted under the USCG Uniform Program's Certification for Insignia and Related Accessories, unless definite color, style, size, materials, or other characteristics have been modified for specific United States Coast Guard's usage.

## III. PROCEDURES FOR OBTAINING CERTIFICATIONS

### A. Certificate Policy

1. Formal certificates issued to insignia manufacturers by the United States Coast Guard will not be changed. If a manufacturer believes a certificate is in error they should inform the Clothing Design and Technical Office. If a change is necessary, the manufacturer shall return the inaccurate certificate to the CDTO for replacement.
2. The Clothing Design and Technical Office will award each manufacturer one certificate number only. This number is applicable to all items produced by that firm, which have been approved by CDTO. Any manufacturer not presently assigned a number will, upon approval, be assigned a certification number by the CDTO.
3. Certificate numbers are awarded to an individual company for its exclusive use. The certificate number awarded to a manufacturer is not for use by other companies which may sell the insignia or accessory supplied by the certificate holder unless the other companies clearly state in their advertisements that these numbers were issued to the manufacturer, not the retailer. The publicizing of certificate numbers in any other manner misleads the consumer by implying that the retailer manufactured the insignia or accessory. Certificate holders should insure that their customers use certificate numbers properly.

### B. Composition of Certificate Numbers.

1. Certification numbers are composed of X-00-CG. The alphanumeric certification number is composed of one letter (derived from the name of the company receiving a certification number), two numbers (determined sequentially), and "CG" to distinguish the number as a United States Coast Guard certification number.

2. The unique certification number assigned to the manufacturer will be issued on an official United States Coast Guard Certificate on which the number(s) will be indicated. The original certificate shall not be altered in any way. The certificate shall be signed by the United States Coast Guard Military Uniform Program's Manager.

### C. Insignia Certification Procedure Overall

1. To obtain certification approval for an insignia or related accessory item, a manufacturer must submit to the USCG Clothing Design and Technical Office three samples of each item for examination and evaluation. Manufacturers will forward the following information with each sample submitted for certification:

- a) Manufacturer's name
- b) Plant at which produced
- c) Specification under which produced
- d) Materials made of

Enclosures (1) thru (3) are provided as templates to insure the proper information accompanies the submitted samples.

2. A laboratory test report, or a Certificate of Compliance in lieu of a laboratory test report shall accompany each item or group of items submitted stating that the item(s) meet or exceed the material(s) specified requirements. The Clothing Design and Technical Office reserves the right to conduct additional tests to verify the submitted test report results.

If the CDTO finds that the item(s) covered by the Certificate of Compliance do not conform to the specified requirements, the manufacturer shall then be required to submit a laboratory report for the item(s) within 30 calendar days.

3. Items submitted for certification will be evaluated for conformance to the item's corresponding specification. Within 45 calendar days of receipt, CDTO notifies the submitter of acceptance, conditional approval or rejection of the submitted item(s).

- a) If approved: The samples will be numbered, and tagged. Sample numbered one (1) will be retained by the Clothing Design and Technical Office, the sample numbered two (2) will be retained by the USCG Uniform Distribution Center, and the sample numbered three (3) will be returned to the manufacturer with corresponding evaluation report and certification letter.

b) If conditionally approved: The samples will be numbered, and tagged. The tag will list the conditions required for production of the item. All of the conditions must be met prior to distribution to Exchanges or the Uniform Distribution Center.

To receive full certification for conditionally approved items; corrected samples can be submitted for inspection following the recertification procedures as described herein.

(1) The reprocessing time frame for resubmitted items will follow the same schedule as initial submittals, as indicated herein.

c) If rejected: The manufacturer will be informed by letter of the deficiencies and must resubmit corrected samples within 30 calendar days. The Clothing Design and Technical Office will retain one of the rejected samples until the next samples are submitted.

(1) The reprocessing time frame for resubmitted items will follow the same schedule as initial submittals, as indicated herein.

4. Once a manufacturer received a Certification of an item authorizes the manufacturer to display their certification number on the certified item. Only certified items shall bear the certification number.

### D. Certification Procedure for Embroidered Insignia Items

1. Manufacturers are required to submit three each (unless quantity is otherwise specified) of the embroidered insignia items for certification. Within 45 calendar days of receipt of the items for certification, the CDTO will notify the submitter by letter of acceptance or rejection and the samples will be numbered, tagged, and returned, or retained in accordance with the insignia certification procedure.

2. Shoulder boards: Three sets\* of following Types and Classes shall be submitted to demonstrate shoulder board construction, proper lace placement, and proper placement of the insignia in accordance with specified requirements:

Type I Class 1	Type III Class 5 Full Size
Type I Class 2	Type III Class 5 Three-Quarter Size
Type I Class 7	Type III Class 5 Full Size
Type I Class 8	Type III Class 5 Three-Quarter Size
Type II Class 4	Type III Class 6 Full Size
Type II Class 5	Type III Class 6 Three-Quarter Size
Type III Class 1 Full Size	Type III Class 7 Full Size
Type III Class 1 Three-Quarter Size	Type III Class 7 Three-Quarter Size
Type III Class 2 Full Size	Type III Class 8 Full Size
Type III Class 2 Three-Quarter Size	Type III Class 8 Three-Quarter Size
Type III Class 4 Full Size	Type IV Class 2

Three sets of the following Types and Classes shall be submitted with a single piece of approved material with three (each) of the specialty marks or designators for Class 3 Shoulder Boards and Type V embroidered sleeve insignia; to demonstrate shoulder board construction, proper lace placement, and proper size and design of the specialty marks or designators in accordance with specified requirements:

Type I Class 3 Chief Warrant Officer  
Type III Class 3 Full Size Chief Warrant Officer  
Type III Class 3 Three-Quarter Size Chief Warrant Officer  
Type IV Class 3 Chief Warrant Officer

Any specialty mark or designator with a left and right design shall have three of the left design, and three of the right design submitted.

\* A set is defined as a pair of shoulder board, to represent each of the ranks defined by the specification. For example the following would represent one set of Type I Class 1 Shoulder Boards:

Type I Class 1 – Admiral  
Type I Class 1 – Vice Admiral  
Type I Class 1 – Rear Admiral (UH)  
Type I Class 1 – Rear Admiral (LH)

3. Rating Badges. Three of each of the following finished Types and Classes shall be submitted with a single piece of approved material with three (each) of the specialty marks or designators for the rating badges; to demonstrate rating badge construction, proper lace placement and proper size and design or the specialty marks or designators in accordance with specified requirements:

Type I Class 1 Boatswain  
Type I Class 2 Boatswain  
Type I Class 3 Boatswain  
Type I Class 4 Boatswain  
Type I Class 5 Boatswain  
Type I Class 6 Boatswain  
Type I Class 7 MCPOCG

Any specialty mark or designator with a left and right design shall have three of the left design, and three of the right design submitted.

### E. Certification Procedure for Metal Insignia Items

1. Manufacturers are required to submit three each (unless quantity is otherwise specified) of the metal insignia items for certification. Within 45 calendar days of receipt of the items for certification, the CDTO will notify the submitter by letter of acceptance or rejection and the samples will be numbered, tagged, and returned, or retained in accordance with the insignia certification procedure.

### F. Certification Procedure for Accessory Items

1. Manufacturers are required to submit three each (unless quantity is otherwise specified) of the accessory items for certification. Within 45 calendar days of receipt of the items for certification, the CDTO will notify the submitter by letter of acceptance or rejection and the samples will be numbered, tagged, and returned, or retained in accordance with the insignia certification procedure.

### G. Certification Procedure for Other Services' Items

1. Manufacturers can submit certificated awarded by other Services' for insignia and related accessories controlled and maintained by other services' specifications. The CDTO retains the ability to deny the other services' certification and request the manufacturer submit samples for the Coast Guard's insignia and related accessories certification evaluation. Other Service's items with modification such as color, finish, size, materials, or other modifications for specific U.S. Coast Guard usage must be submitted to the CDTO for evaluation.

2. Other Service's certificates that are approved for use by the CDTO will be valid for no longer than five (5) years from the issue date, or for the length of time pre-determined by the issuing Service. If the Service terminates the certification prior to the length of the certificate the manufacturer must submit samples to the CDTO for certification.

### H. Location of Certification Numbers on End Items and Packaging

1. The certification number shall be applied by the manufacturer and no other firm or person is authorized to apply this number. By applying the certification number to the item, the manufacturer guarantees that the item has been produced in accordance with the applicable requirements.
2. Embroidered Insignia.
  - a) Embroidered items that cannot be directly marked, labeled, or printed on shall be identified with the manufacture's name and certification number on the items individual package or on bulk packaging.
  - b) Shoulder boards shall be stamped on the reverse side where placement of marking will not interfere with the integrity of the insignia.
3. Metal Insignia.
  - a) Metal Insignia items shall be debossed or embossed on reverse side where placement of markings will not interfere with the integrity of the insignia.
4. Accessory Items.
  - c) Accessory items that cannot be directly marked, labeled, or printed on shall be identified with the manufacture's name and certification number on the items individual package or on bulk packaging. Accessory items that can be stamped shall have the markings placed where the marking will not interfere with the integrity of the accessory item. Accessory items with metal components that can be debossed or embossed shall have the markings placed where the marking will not interfere with the integrity of the accessory item.

## I. Certificate Revocation

1. Certification may be revoked at any time if it is determined by the Clothing Design and Technical Office that the certificate holder has violated any of the expressed conditions under which the certification was issued. These include, but are not limited to:

- a) Use of non-certified fabrics, materials, or component parts.
- b) Workmanship is not at an acceptable level for quality when compared to the specifications' requirements, or a certified standard sample.
- c) Component material or parts are not equivalent to the specifications' requirements, or a certified standard sample.
- d) Labeling requirements are not as prescribed by the Certification Program.
- e) Failure to submit item(s) for recertification.
- f) Failure of prime contractor to advise the CDTO of a change to subcontractor and/or manufacturing facilities.
- g) Failure to allow the CDTO personnel access to contractor(s) and/or subcontractor(s) prime manufacturing or warehousing facilities.

2. Notice of the first violation will be given to the contractor in writing by the Clothing Design and Technical Office and will constitute a warning. The contractor will be required to respond in writing within 14 calendar days indicating:

- a) The action being taken to recertify the noted shortcomings.
- b) When and where the corrected products can be inspected.

3. The next violation of the same infraction(s) will be grounds for revocation by the CDTO, who will notify the contractor of the revocation in writing. The length of the certificate revocation period will be based on the severity of the infraction.

4. The Exchanges and the Uniform Distribution Center will be notified of the certificate revocation, and they will determine on a case by case basis whether or not to screen their inventory to return the specific item(s) to the contractor.

### J. Transferring Certificates

1. Certificate number(s) are considered transferable as part of a sale of a company. The Clothing Design and Technical Office will be notified by letter of any sale action. An evaluation of the new company may be required prior to the transference of the certificate number(s) focusing on (but not limited to) the following areas:

- a) Manufacturing capabilities.
- b) Facilities acceptability.
- c) Quality assurance plans and procedures.
- d) Submission of sample items for inspection.

### K. Reinstating Certificates

- 1. The minimum revocation period will be one year. Reinstatement of a manufacturer's certification may be made after the revocation period by product re-submittal, and item approval.
- 2. If the resubmitted product is deemed acceptable, a new certification number will be issued. Old certificate numbers will not be reissued.

## IV. RECERTIFICATION OF ITEMS

A. Manufacturers are required to submit three (unless quantity is otherwise specified) of each of the embroidered insignia, metal insignia, or accessory items for certification every five years. The first submission for recertification will be five years after the initial certification date. A recertification notification will be furnished to manufacturers 45 days prior to the date of expiration of each item. Within 45 calendar days of receipt of the items for recertification, the CDTO will notify the submitter by letter of acceptance or rejection and the samples will be numbered, tagged, and returned, or retained in accordance with the insignia certification procedure.

B. The recertification number will be the same number as the original certification.

## V. ITEMS TO BE CONTROLLED

A. Any embroidered and metal insignia, and accessory item worn by United States Coast Guard Members and purchased by the United States Coast Guard requires verification, validation, and certification under the United States Coast Guard Uniform Program's Clothing Design and Technical Office.

B. Any embroidered and metal insignia, and accessory item controlled by another Service and worn by United States Coast Guard Members and purchased by the United States Coast Guard require verification, validation, and certification under the controlling Service or by the United States Coast Guard Uniform Program's Clothing Design and Technical Office. Procedures for submitting Certification Numbers and Certificates maintained by another Service can be found in Section III herein.

C. A request for a complete list of insignia items and accessories including types, classes, and designators can be sent to the Clothing Design and Technical Office. An address for the CDTO is located in Section IX herein.

### VI. SPECIFICATIONS

#### A. Obtaining Specifications

1. A list of specifications for Coast Guard Insignia and Accessories is located in Section X herein. Specifications can be obtained through the Clothing Design and Technical Office, or online at <http://quicksearch.dla.mil>.

#### B. Patents

1. If the specification includes components covered by patents under which the Government has a license, such license applies only to Government procurement. It does not apply to production under the U.S. Coast Guard Uniform Certification Program.
2. Manufacturers may use patented components of the applicable specification and specific structural details of the item, whether patented or not, in order to obtain an approval certification so long as the item otherwise meets requirements and equals or exceeds the applicable specifications.

## VIII. END ITEM EVALUATION AND INSPECTIONS

### A. Evaluation Criteria

1. The important factors considered by the U.S. Coast Guard when evaluating end items include but are not limited to the following areas:
  - a) Basic materials and components used in fabrication:
    - (1) Shade
    - (2) Quality
    - (3) Conformance to specification(s)
  - b) Production techniques and in-process item management:
    - (1) Cleanliness
  - c) End item inspection and quality control procedures:
    - (1) Calibrated environment, tools, and proper testing equipment.
    - (2) Standards and certified samples for evaluations.
  - d) Packaging and packing:
    - (1) Conformance to contract requirements.
    - (2) Appropriate for the item.
  - e) Inventory of end items:
    - (1) Inventory control procedures.
    - (2) Properly maintained environment.

### B. Sample Submittal Requests

1. At any time the Clothing Design and Technical Office may request sample submittals from the manufacturer, Exchange, or the Uniform Distribution Center stock for evaluation and verification against the certified tagged standard sample and applicable requirements.

### C. Plant and Warehouse Inspections

1. Plant and warehouse inspections will be made by the Clothing Design and Technical Office personnel to verify manufacturers and subcontractor's facilities meet the standards required to produce an end item with the quality established by the tagged certified sample. Inspections will be both announced and unannounced.

### D. Exchange(s) and The Uniform Distribution Center Inspections

1. Scheduled inspection visits will be made to Exchange(s) and the Uniform Distribution Center to inspect items for conformance and quality including packaging, packing, and labeling requirements.

### E. Reporting Inspection Results and Follow-up Corrective Action

1. After completing a field inspection visit to either a manufacturer's facility or an Exchange or the Uniform Distribution Center, a complete report detailing all findings is prepared by Clothing Design and Technical Office for use by the USCG Contracting Officers, the Exchanges, and the Uniform Distribution Center.
2. A manufacturer will receive a copy of the inspection report via the USCG Contracting Official overseeing the contract covering the items contained in the inspection report.
  - a) Manufacturers can submit any questions regarding the inspection report to the Clothing Design and Technical Office.
3. In the event that corrective action is required to eliminate deficiencies noted during inspections, the Clothing Design and Technical Office will follow up with the manufacturer(s) and sub-contractors via correspondence and/or additional facility visits.
  - a) The USCG Contracting Official(s), the Exchanges(s), and the Uniform Distribution Center will be advised of all corrective actions being taken via correspondence copy.
