

(vi) Description of Requirement (including a list of any attachments)

Item 0001 – Tack Room Shed

The Ouray Ranger District, Grand Mesa, Uncompahgre, and Gunnison National Forests (GMUG) is soliciting for purchase and deliver a prefabricated 14'x28' building for equestrian use. Building will have an 8'x14' tack room with loft and two 9.5'x14' bays/stalls attached to the tack room on either side. Building shall be prefabricated and moveable. Tack room will be located in the center of the building between the two 9.5'x14' bays/stalls and have a raised roof to accommodate the loft. Front of the building will provide access to the tack room through a 6' double door rear that will provide access for horses to stalls.

The center room will be used to store horse related supplies. The layout of the building per the specs is important due to the space that the Ouray Ranger District will be using the shed in conjunction with a corral design, see attached picture for the building layout. The two stalls may be used for hay storage or loafing sheltered area. See generalized picture below showing both sides:


1. Walls shall be 7' high (minimum) constructed with 2in x 4in studs on 16 in center.
2. 6in x 6in pressure-treated base with D rings
3. ½" plywood roof sheathing
4. ¾" plywood flooring in tack room
5. 4" overhang on sides
6. L type corners
7. Overlapping Double top Plate
8. Engineered roof trusses
9. 1in x 4in cedar trim
10. Fir plywood T1-11 siding
11. Metal roof, Hunter green
12. One, 2in x 2in wood window in Gable
13. Two (2), 3in x 3in wood windows for stalls front side of building
14. Entry doors from tack room to stalls
