SUBJECT: Brand Name Exact Match Memo for Unison Buy MYERMDWEM2402

1. Procurement of the items listed below is essential to meeting the needs of support for the musical, theatrical, ceremonial and televised events that are conducted in The United States Army Band "Pershing's Own" in Fort Myer, Virginia. The requested items are required to support audio production requirements and provide Conmy Hall with the capability of producing professional quality performances for dignitaries and the public. The items requested will replace items due for pending life-cycle replacement. The items listed below match the current audio equipment infrastructure of the facility and will require minimal installation for transition to new product usage. No other audio production devices match the level of professional quality the items below will provide. In accordance with AR 220-90 paragraph 6-1(b-c), the sound and video engineer has the responsibility for the procurement of professional-level audio equipment. Professional quality audio equipment is paramount for the organization as this level of product has an amount of durability and visual quality not found in base-level brands. IAW AR 220-90, para 6-1(b-c), the following audio equipment is considered to be within the scope of professional quality, meet the serviceability standards needed to fulfill operational mission requirements as determined by the video production engineer and the Commander, The United States Army Band "Pershing's Own."
