JBMHH UPH Washer & Dryer Rental and Maintenance Services
Part I
General Information.

1. Provide non personal maintenance and repair services in order to maintain clean, safe, livable conditions for Military Family Housing (MFH) units with minimal impact to the residents.

1.1 Description of Services/Introduction: The Contractor shall provide personnel, equipment, supplies, facilities, transportation, tools, materials, parts, supervision, and necessary to perform the washer and dryer rental maintenance services for all 8 Unaccompanied Personnel Housing Buildings (UPH). There are one (1) performance locations for this UPH Washer and Dryer Rental Maintenance Services contract: Fort Myer, VA., Fort Myer is in Arlington, VA., and it is adjacent to Arlington National Cemetery. Fort Myer has a total of Eight (8) UPH buildings. Fort Myer is currently known as Joint Base Myer-Henderson Hall (JBMHH) as defined in this Performance Work Statement (PWS). The Contractor shall perform to the standards of this PWS.

1.2 Background: The JBMHH has high visibility and the daily ceremonial requirements make the standards of this well in excess of those normally encountered in Government contracts. Fort Myer, the ceremonial home of the U.S. Army by virtue of its geographic location adjacent to Arlington National Cemetery, the Pentagon hosts many high-ranking general officers and visiting foreign dignitaries daily. Fort McNair is a home of National Defense University, National War College, and several other important entities. The single Soldiers residing on the UPH buildings participate in most of the ceremonial events, funerals, parades. Having functional machines at each of the UPH buildings is essential to ensure Soldiers have clean attire/uniform and to ensure their appearance is impeccable and their attire/uniform to the upmost perfection.

1.3 Scope: Contractor shall furnish commercial energy start rated cloth washer and dryers, labor, supervision, materials, equipment, transportation, parts and supplies necessary to replace, maintain, repair the contractors' commercial energy star rated automatic top load clothe washers and dryers in specified buildings, as listed in Exhibit I. All work shall be accomplished in strict accordance with the intent and scope of these specifications.

1.3.1 The Contractor shall provide parts to repair, service and maintain all the government owned commercial washer and dryers as shown on Exhibit 1. Exhibit 1 shows the number of government owned cloth washer and dryers at Fort Myer. All work shall be accomplished in strict accordance with the intent and scope of these specifications.

1.4 Period of Performance: the period of performance for this contract is one base year of 9 months plus four options years of 12 months each. The POP are as follows:

Base Year: March 1 2023 to 31 Dec 2023
Option Year I: Jan 1 2024 to 31 Dec 2024
Option Year II: Jan 1 2025 to 31 Dec 2025
Option Year III: Jan 1 2026 to 31 Dec 2026
Option Year IV: Jan 1 2024 to 31 Dec 2027

1.5 Technical Government Representation: The technical representative is the Contracting Officer's Representative (COR), who is responsible for the following functions of this contract:

- a. Technical inspection

- b. Recommended approval of equipment, brochures, samples and materials.
- c. Execution of receiving reports.

1.6 Coordination of Work Operations: The contractor, prior to starting any work under this contract, shall coordinate all the work operations with the COR to walk through the UPH locations; identify the location of the machines in each building and to verify the number of machines at each locations that are cover under this contract. The COR will identify the Government owned machines and will show the contractor where the leased machines are located.

1.7 Storage: The government will not be provided any type of storage to the contractor under this contract. Therefore; the contractor shall not store materials and/or equipment in any area on post.

1.8 Interruption of Utilities: The Government shall provide the utilities or electricity and water to operate the clothes washer and dryer. The contractor shall not interrupt existing utilities on any of the building under this contract without prior approval and coordination from the COR.

1.9 Disposal of Equipment or Debris: The contractor shall not dispose of any equipment or debris post. The requirement set forth in this section are mandatory and shall be strictly adhered to by the contractor. Trash-debris is defined and shall be disposed of as hereinafter specified:

- a. Definition of trash-debris: All material of every type of description generated as a result of the installation and maintenance of appliances.
- b. In the event the contractor or subcontractor dumps trash-debris in any area of the post, the contractor shall be required to retrieve the same and dispose of it as outlined in these specifications.

1.10 Hours of Operation and Holidays: All work shall be conducted during normal duty hours (07:30 – 17:00, Monday through Friday except on Federal Holidays or when the Government Facilities are closed due to local or national emergencies, administrative closings or similar directed facility closings. Any calls received Saturday, Sunday or on holidays shall be completed by close of business on the first regular work day following notification.

The Contractor must at all times maintain an adequate work force for the uninterrupted performance of all tasks defined within this performance work statement when the Government facility is not closed for the above reasons. When hiring personnel, the Contractor shall keep in mind that the stability and continuity of the work force are essential. Following is the list of the Federal Holidays:

1.11 Clean Up: Contractor shall clean work areas after each service call. All paper, wrappings, cardboard, etc., shall be placed in tightly closed containers for disposal off post. All cleaning shall be done by the contractor at no additional cost to the government.

1.12 Technical Provisions: Contractor shall furnish all labor, equipment and materials, parts to include flex hose to perform all operations related to the installation, maintenance, repair and replacement of the rental/leased washers and dryers of the contractors' owned machines. The contractor shall only do repairs, connect (if necessary), maintain, provide parts and service the government owned machines. See list under Exhibit 1.

1.13 Rental/Leased Machines: The contractor shall provide brand new energy star rated washer and dryers under this contract in those building listed on the Exhibit #1 where the machines are contractor owned.

1.14. Rental washer and dryers: The rental washer and dryers being replaced under this contract shall be brand new, clean and free of all dents and/or scratches or otherwise damaged. All rental/leased machines will be replaced, installed and maintained by the contractor. At no time the contractor shall hold machines with tape, patch or paint the washer and dryers

1.15. Specifications for Rental washer and dryers: The contractor shall replace the rental washers and dryers with energy star Whirlpool rated machines that the contractor shall provide under this contract.

A. COMMERCIAL ENERGY STAR WHIRLPOOL RATER ELECTRIC WASHERS: Shall be top load, or an approved equal, meeting or exceeding the following minimum requirements:

1. Commercial electric washers with a minimum load capacity of 18 pounds.
2. Non-coin operated.
3. Contain basic regular and gentle wash cycles.
4. Bear operating instructions for users.

B. COMMERCIAL ENERGY STAR WHIRLPOOL RATED ELECTRIC DRYER shall be front load, or an approved equal, meeting the following minimum requirements:

1. Commercial electric dryers with a minimum load capacity of 18 pounds.
2. Non-coin operated.
3. Electrically operated 200/240v, 60Hz, with a prong to fit the outlet plug.
4. Contain basic regular and permanent press drying cycles.
5. Timer for drying period, minimum of 0-60 minutes capability.
6. Interlock safety switch to stop dryer when door is open.
7. Bear operations instructions for users.

Any deviation/changes to the above specification must be approved by the COR.

1.14 Non-Personnel Services: Furnish necessary labor, materials, parts and equipment to provide washer and dryer service and maintenance, as set forth in section 1

1.15 Liability: The government shall be indemnified from liability for any and all responsibility for damage to property or for injuries or death to persons who occur without fault or negligence on the part of the government. The contractor shall save the government harm from any and all claims arising from such causes.

1.16 Removal of Contractors Employees: The contractor agrees to use only experienced, responsible and capable people to perform contractor work. The COR may require that the contractor remove from the job site employees who endanger persons or property, or whose continued employment is inconsistent with interests of military security.

1.17 Utility Connections: The government shall provide the necessary utility connections for the operation of washers and dryers. This will include hot and cold water connections for washers, electricity for dryers. However, all modifications deemed necessary to accommodate contractor owned equipment shall be at the contractor's expense. The government shall also provide and install the exterior vent. The contractor shall Connect the machines to the necessary utility connections and shall install the flex hose for the dryers accordingly. The flex hose shall be attached neatly and it shall not be taped or piece together.

1.18 Utilities: The utilities required for the operation of washers and dryers will be provided by the government. This will include hot and cold water and electricity.

1.19 Removal of Equipment at the End of Contract: The removal of the contractor owned washer and dryers will be coordinated with the installation of machines under the new contract. No location will be without equipment for more than 48 hours. Contractor shall bill only for the days that contractor owned machines were actually in operation.

1.2. Phase In/Phase Out: To minimize any decreases in productivity and to prevent possible negative impacts on additional services, the Contractor shall have key personnel on board during the 30-day phase in/ phase out periods. The Contractor shall, upon the Contracting Officer's written notice, (1) furnish phase-in and phase-out services for up to thirty days after this contract expires and (2) negotiate in good faith a plan with a successor to determine the nature and extent of phase-in and phase-out services required. The plan shall specify a training program and a date for transferring responsibilities for each division of work described in the plan, and shall be subject to the Contracting Officer's approval. The Contractor shall provide sufficient experienced personnel during the phase-in and phase-out period to ensure that the services called for by this contract are maintained at the required level of proficiency.

2. STANDARDS OF PERFORMANCE FOR CONTRACTOR OWNED AND GOVERNMENT OWNED EQUIPMENT TO BE PERFORMED AT CONTRACTOR EXPENSE:

- a. The contractor shall clean and wipe down each machine, clean the immediate area and remove debris or trash each time a machine(s) is/are serviced. The Contractor is responsible to remove, clean and replace all ducts on Dryer.
 - b. The contractor shall provide a 24/7 phone line and phone number for receiving trouble calls 24 hours a day, seven (7) days a week.
 - c. The contractor shall repair any contractor owned and government owns machines within the next working day after receiving notification of any machine(s) needing service or that are not inoperable.
 - d. The contractor shall replace any contractor owned machine(s) within the next working day after verification and receiving notification that the machine(s) is/are no longer serviceable. Contractor owned machines will be replace with contractor owned new machines (not previously used). The contractor shall at times let the COR know of any contract leased machines replacement.
 - e. The contractor shall notify the COR when a Government owned machine(s) is/ are no longer serviceable/ repairable in order for the COR to notify the appropriate government personnel to procure a new machine.
 - f. The contractor shall replace, a contractor owned machine which malfunctions three (3) times during any 10 working day period. The contractor shall replace the contractor owned inoperable/unserviceable machine(s) with a new contractors owned machine(s) within 24 hours after notification, in writing, from the COR.
 - g. The Government will provide to the contractor the list of JBMHH names that will be authorized to call the service calls to their office. The contractor shall notify the COR when unauthorized personnel are calling reporting service calls.
1. The contractor or contractor's employee shall report to the CQ desk, Supply Clerk of the building when responding to work order call. The contractor employee shall have a work order ticket listing the nature of the call. Upon completion of the repairs, the contractor employee shall provide a copy of the work order ticket stating, work performed, machine #, functionality of the machine, employee name, time and date of service, In addition, state if the machine is awaiting replacement parts.

2.1 New Installations: The contractor shall provide new contractor owned washers and dryers for service to new renovated sites within seven (7) calendar days after notification by the COR. (If applicable). This applies to building(s) that go under renovations and they already have contractor owned machines.

2.2 The contractor shall service and maintain all government owned washer and dryers until beyond economical repair. The life expectance methodology in non-tropical areas for household appliances is 7-15 years as it is stated in DA PAM 420-1-1 para 2-14d. (Dated 2Apr09).

2.3 Liability to Military Personnel: Contractor shall be responsible for replacement or repair of articles that may be damaged because of oil or grease leaking from machine onto clothing while the clothing is being cleaned or dried in the machine(s).

2.4 Identification of Personnel and Vehicles: The contractor's personnel working at Ft. Myer shall be identified by lettering stating the contractor's name and the employee's name. The vehicles shall have the company name on the vehicle. All vehicles will have a current state inspection decal and will be registered at the post vehicle registration station.

2. Vandalism: Any act of vandalism discovered by the contractor shall be reported immediately to the COR or the facility manager of the building where the machines are located.
3. Signs and Decals: The contractor shall provide, at each machine, the necessary signs or decals to provide the operator instructions. The contractor shall attach to each machine a decal indicating telephone numbers and instructions for contacting the proper personnel in case of machine malfunction. Each machine shall have an identification number on it to indicate machine being reported for service. The contractor shall also mark the Government owned machines that identify them from the contractors' machines.
4. Accident Prevention: In order to provide controls for personal safety, prevention of damage to property, materials, supplies and equipment, and to avoid interruption of performance under this contract, contractor shall comply with all pertinent provisions of the manual "Safety Requirements", approved by the Chief of Engineers, and as may be further amended. Contractor shall take, or cause to be taken, such additional measures as may be determined by the Contracting Officer to be reasonable necessary for that purpose. Copy of manual is available at the contracting office.
 - a. The contractor shall maintain accurate records of, and shall report to the COR, exposure data and all accidents resulting in death, traumatic injury, occupational disease, and/or damage to property, materials, supplies and equipment incident to work performed under this contract on forms prescribed by the COR.
 - b. The Contracting Officer shall notify the contractor of any noncompliance with the foregoing provisions and the action to be taken. The contractor shall, after receipt of notice, immediately correct the deficiencies. Such notice, when delivered to the contractor or his/her representative at the site of work, shall be deemed sufficient for this purpose. If the contractor fails or refuses to comply promptly, the COR may issue an order stopping payment on work performed under this contract until satisfactory corrective action has been taken.

2.5. Permits and Responsibility for Work: The contractor shall, without additional expense the government, obtain all licenses and permits required for the execution of the work. The contractor shall be responsible for all damages to property or personal injury that occurs as a result of the contractor's employee fault or negligence in connection with the execution of the work.

2.6. Payment: Payment will be made not more than once each calendar month. Invoices shall be submitted by the contractor via the Wide Area Work Flow (WAWF) after the close of each calendar month to cover service performed during the prior calendar month. It is mutually agreed that failure to satisfactorily accomplish work in contractor, constitutes a deficiency. All work will be regularly inspected by the COR and any deficiencies will be reported in writing to the contractor. All deficiencies shall be corrected within 24 hours after written notification from the COR. The COR will report the deficiencies that are not corrected within the time line stated in this PWS

on the COR Monthly reporting. The Contracting Officer (KO) will make the sole determination as to the existence of a deficiency in performance and the timeliness of a deficiency corrections. When all the services have been deemed acceptable, the COR will accept the services provided by accepting the contractors invoice in Wide Area Workflow (WAWF) <https://wawf.eb.mil/>.

2.7. Project Manager: The contractor shall provide the name and phone number of the have a project manager, who must have the authority to make decisions concerning repairs and maintenance, when the contractor is not available. The contractor's project manager shall provide a copy of the ticket of the maintenance/services perform on a particular machine describing the work done, or if a part has to be order or if the machine will have to be replaced. The project manager shall provide to the COR a copy of the monthly log of the machines serviced at the end of each calendar month. This can be email as an attachment or it can also be attached as part of the monthly invoice with an attachment in Wide Area Work Flow (WAWF).

2.8. Physical Security: The Contractor shall safeguard all government equipment, information and property provided for Contractor use (if applicable). Contractor shall maintain a physical security checklist/log which will be forwarded to the COR on a monthly or quarterly basis. At the close of each work period, government facilities, equipment, and materials shall be secured.

2.9 COMMON ACCESS CARDS/ SECURITY REQUIREMENTS: Installation Access – Vetting (CAC): PERSONAL IDENTITY VERIFICATION OF CONTRACTOR PERSONNEL (SEPT 2007), (a) The Contractor shall comply with agency personal identity verification procedures identified in the contract that implement Homeland Security Presidential Directive-12 (HSPD-12), Office of Management and Budget (OMB) guidance M-05-24 and Federal Information Processing Standards Publication (FIPS PUB) Number 201. (b) The Contractor shall insert this clause in all subcontracts when the subcontractor is required to have routine physical access to a Federally-controlled facility and/or routine access to a Federally-controlled information system. Any costs associated with the background checks are the responsibility of the contractor, sub-contractor, or individual. Installation Access / Requirements Regarding Personnel Not Requiring Common Access Card (CAC): Contractor and all associated sub-contractors employees shall comply with adjudication standards and procedures using the National Crime Information Center Interstate Identification Index (NCIC-III) and Terrorist Screening Database (TSDB) (Army Directive 2014-05/AR 190-13), applicable installation, facility and area commander installation/facility access and local security policies and procedures (provided by government representative), or, at OCONUS locations, in accordance with status of forces agreements and other theater regulations.

2.10 iWATCH TRAINING, AT Level I TRAINING AND OPSEC TRAINING:

All contractor employees, to include subcontractor employees, requiring access Army installations, facilities and controlled access areas shall complete AT Level I awareness training within 30 calendar days after contract start date or effective date of incorporation of this requirement into the contract, whichever is applicable. The contractor shall submit certificates of completion for each affected contractor employee and subcontractor employee, to the COR or to the contracting officer, if a COR is not assigned, within 07 calendar days after completion of training by all employees and subcontractor personnel. AT level I awareness training is available at the following website: <http://jko.jten.mil>. The contractor and all associated sub-contractors shall brief all employees on the local iWATCH program (training standards provided by the requiring activity ATO). This local developed training will be used to inform employees of the types of behavior to watch for and instruct employees to report suspicious activity to the COR. This training shall be completed within 30 calendar days of contract award and within 14 calendar days of new employees commencing performance with the results reported to the COR NLT 07 calendar days after contract award.

3.0 Installation Access/Purpose of Access: The Contractor shall maintain awareness of contractor or subcontractor employees who have been vetted and approved to access the installation and shall notify the COR and KO in writing within 48 hours of any contractor or sub-contractor employee who resigns, is terminated, or for any other reason is no longer authorized to access JBM-HH for the purpose of performance of this contract. For contracts with a performance period longer than three months, the Contractor shall reconcile his roster of currently-approved personnel with the JBM-HH Visitor Control Center (VCC) to ensure that both the Contractor and COR maintain accurate awareness of the contractor and subcontractor employees who are authorized to access the installation.

3.1 Surrender Common Access (CACs): If applicable, the Contractor shall ensure that all contractor and sub-contractors employee Common Access Cards (CACs), badges, passes or other access credentials which were issued under this contract are surrendered to the COR upon completion of the contract. CACs, badges, passes and other access credentials are DOD property and failure to surrender them may be punishable under 18 USC § 701.

3.2 Quality Assurance: The government shall evaluate the contractor's performance under this contract in accordance with the Quality Assurance Surveillance Plan (QASP). This plan is primarily focused on what the Government must do to ensure that the contractor has performed in accordance with the performance standards. It defines how the performance standards will be applied, the frequency of surveillance, and the minimum acceptable defect rate(s). The QASP is a government document only and will not be incorporated into this contract.

3.3 Unsatisfactory Performance: If the COR determines that any aspect of the contract is performed in an unsatisfactory manner, the unsatisfactory component shall be documented by the COR and brought to the attention of the contractor and the KO. When performance does not conform to contract requirements, the government may require the Contractor to perform the services again at no additional cost to the government. Appropriate action shall be taken by the contractor to resolve any unsatisfactory performance immediately. If any unsatisfactory performance of the contract continues or becomes habitual, the COR shall notify the KO and steps will be taken in compliance with Federal Acquisition Regulation (FAR Part 49). The COR will use the technical Exhibit #2 (PRS) to rate the contractors performance.

3.4 ACCIDENT PREVENTION/EMERGENCY MEDICAL SERVICES: The contractor shall comply with all pertinent provisions of the current "General Safety Requirements", EM-385-1-1, and shall take measures as the COR determines to be necessary to prevent accidents.

3.5 The contractor shall maintain an accurate record of all accidents resulting in death, traumatic injury, occupational diseases, and damage to property, materials, supplies, and equipment incident in performance of work under this contract.

3.6 Accident Reports: Submit to the COR any occurrence of an accident on DA Form 285-1 within three working days of an accident.

3.7 Emergency medical treatment and services for Contractor personnel is the responsibility of the Contractor.

3.8 Contractor Manpower Reporting. The contractor shall report all contractor labor hours (including subcontractor labor hours, if applicable) required for performance of services provided under this contract via a secure data collection site. The contractor is required to completely fill in all required data fields using the following web address: <http://www.ecmra.mil/>, and then click on "Department of the Army CMRA" or the icon of the DoD organization that is receiving or benefitting from the contracted services. Reporting inputs will be for the labor executed during the period of performance during each Government fiscal year (FY), which runs October 1 through September 30. While inputs may be reported any time during the FY, all data shall be reported no later than October 31 of each calendar year. Contractors may direct questions to the help desk by clicking on "Send an email", which is located under the Help Resources ribbon on the right side of the login page of the applicable Service's/Component's CMR website.

3.9 Contractor Performance Assessment Reporting System (CPARS) Documented surveillance data IAW this QASP will be used as objective data to support CPARS ratings. The inclusion of detailed documented inspection results provides objectivity to CPARS reporting. CPARS will be accomplished annually or at the end of a Task Order whichever occurs first.

52.204-24 REPRESENTATION REGARDING CERTAIN TELECOMMUNICATIONS AND VIDEO SURVEILLANCE SERVICES OR EQUIPMENT (NOV 2021)

The Offeror shall not complete the representation at paragraph (d)(1) of this provision if the Offeror has represented that it "does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument" in paragraph (c)(1) in the provision at 52.204-26, Covered Telecommunications Equipment or Services-- Representation, or in paragraph (v)(2)(i) of the provision at 52.212-3, Offeror Representations and Certifications- Commercial Products and Commercial Services. The Offeror shall not complete the representation in paragraph (d)(2) of this provision if the Offeror has represented that it "does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services" in paragraph (c)(2) of the provision at 52.204-26, or in paragraph (v)(2)(ii) of the provision at 52.212-3.

(a) Definitions. As used in this provision-

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Predecessor" means an entity that is replaced by a successor and includes any predecessors of the predecessor.

"Reasonable inquiry" has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate--

HEALTH & WELFARE: \$4.80 per hour, up to 40 hours per week, or \$192.00 per week or \$832.00 per month

HEALTH & WELFARE EO 13706: \$4.41 per hour, up to 40 hours per week, or \$176.40 per week, or \$764.40 per month*

*This rate is to be used only when compensating employees for performance on an SCA-covered contract also covered by EO 13706, Establishing Paid Sick Leave for Federal Contractors. A contractor may not receive credit toward its SCA obligations for any paid sick leave provided pursuant to EO 13706.

VACATION: 2 weeks paid vacation after 1 year of service with a contractor or successor, 3 weeks after 5 years, and 4 weeks after 15 years. Length of service includes the whole span of continuous service with the present contractor or successor, wherever employed, and with the predecessor contractors in the performance of similar work at the same Federal facility. (Reg. 29 CFR 4.173)

HOLIDAYS: A minimum of eleven paid holidays per year: New Year's Day, Martin Luther King Jr.'s Birthday, Washington's Birthday, Memorial Day, Juneteenth National Independence Day, Independence Day, Labor Day, Columbus Day, Veterans' Day, Thanksgiving Day, and Christmas Day. (A contractor may substitute for any of the named holidays another day off with pay in accordance with a plan communicated to the employees involved.) (See 29 CFR 4.174)

THE OCCUPATIONS WHICH HAVE NUMBERED FOOTNOTES IN PARENTHESES RECEIVE THE FOLLOWING:

1) **COMPUTER EMPLOYEES:** This wage determination does not apply to any individual employed in a bona fide executive, administrative, or professional capacity, as defined in 29 C.F.R. Part 541. (See 41 C.F.R. 6701(3)). Because most Computer Systems Analysts and Computer Programmers who are paid at least \$27.63 per hour (or at least \$684 per week if paid on a salary or fee basis) likely qualify as exempt computer professionals under 29 U.S.C. 213(a)(1) and 29 U.S.C. 213(a)(17), this wage determination may not include wage rates for all occupations within those job families. In such instances, a conformance will be necessary if there are nonexempt employees in these job families working on the contract.

Job titles vary widely and change quickly in the computer industry, and are not determinative of whether an employee is an exempt computer professional. To be exempt, computer employees who satisfy the compensation requirements must also have a primary duty that consists of:

(1) The application of systems analysis techniques and procedures, including consulting with users, to determine hardware, software or system functional specifications;

(2) The design, development, documentation, analysis, creation, testing or modification of computer systems or programs, including prototypes, based on and related to user or system design specifications;

(3) The design, documentation, testing, creation or modification of computer programs related to machine operating systems; or

(4) A combination of the aforementioned duties, the performance of which requires the same level of skills. (29 C.F.R. 541.400).

Any computer employee who meets the applicable compensation requirements and the above duties test qualifies as an exempt computer professional under both section 13(a)(1) and section 13(a)(17) of the Fair Labor Standards Act. (Field Assistance Bulletin No. 2006-3 (Dec. 14, 2006)). Accordingly, this wage determination will not apply to any exempt computer employee regardless of which of these two exemptions is utilized.

2) **AIR TRAFFIC CONTROLLERS AND WEATHER OBSERVERS - NIGHT PAY & SUNDAY PAY:** If you work at night as part of a regular tour of duty, you will earn a night differential and receive an additional 10% of basic pay for any hours worked between 6pm and 6am.

If you are a full-time employed (40 hours a week) and Sunday is part of your regularly scheduled workweek, you are paid at your rate of basic pay plus a Sunday premium of 25% of your basic rate for each hour of Sunday work which is not overtime (i.e. occasional work on Sunday outside the normal tour of duty is considered overtime work).

**** HAZARDOUS PAY DIFFERENTIAL ****

An 8 percent differential is applicable to employees employed in a position that represents a high degree of hazard when working with or in close proximity to ordnance, explosives, and incendiary materials. This includes work such as screening, blending, drying, mixing, and pressing of sensitive ordnance, explosives,

and pyrotechnic compositions such as lead azide, black powder and photoflash powder.

All dry-house activities involving propellants or explosives. Demilitarization, modification, renovation, demolition, and maintenance operations on sensitive ordnance, explosives and incendiary materials. All operations involving re-grading and cleaning of artillery ranges.

A 4 percent differential is applicable to employees employed in a position that represents a low degree of hazard when working with, or in close proximity to ordnance, (or employees possibly adjacent to) explosives and incendiary materials which involves potential injury such as laceration of hands, face, or arms of the employee engaged in the operation, irritation of the skin, minor burns and the like; minimal damage to immediate or adjacent work area or equipment being used. All operations involving, unloading, storage, and hauling of ordnance, explosive, and incendiary ordnance material other than small arms ammunition. These differentials are only applicable to work that has been specifically designated by the agency for ordnance, explosives, and incendiary material differential pay.

**** UNIFORM ALLOWANCE ****

If employees are required to wear uniforms in the performance of this contract (either by the terms of the Government contract, by the employer, by the state or local law, etc.), the cost of furnishing such uniforms and maintaining (by laundering or dry cleaning) such uniforms is an expense that may not be borne by an employee where such cost reduces the hourly rate below that required by the wage determination. The Department of Labor will accept payment in accordance with the following standards as compliance:

The contractor or subcontractor is required to furnish all employees with an adequate number of uniforms without cost or to reimburse employees for the actual cost of the uniforms. In addition, where uniform cleaning and maintenance is made the responsibility of the employee, all contractors and subcontractors subject to this wage determination shall (in the absence of a bona fide collective bargaining agreement providing for a different amount, or the furnishing of contrary affirmative proof as to the actual cost), reimburse all employees for such cleaning and maintenance at a rate of \$3.35 per week (or \$.67 cents per day). However, in those instances where the uniforms furnished are made of ""wash and wear"" materials, may be routinely washed and dried with other personal garments, and do not require any special treatment such as dry cleaning, daily washing, or commercial laundering in order to meet the cleanliness or appearance standards set by the terms of the Government contract, by the contractor, by law, or by the nature of the work, there is no requirement that employees be reimbursed for uniform maintenance costs.

**** SERVICE CONTRACT ACT DIRECTORY OF OCCUPATIONS ****

The duties of employees under job titles listed are those described in the ""Service Contract Act Directory of Occupations"", Fifth Edition (Revision 1), dated September 2015, unless otherwise indicated.

**** REQUEST FOR AUTHORIZATION OF ADDITIONAL CLASSIFICATION AND WAGE RATE, Standard Form 1444 (SF-1444) ****

Conformance Process:

The contracting officer shall require that any class of service employee which is not listed herein and which is to be employed under the contract (i.e., the work to

be performed is not performed by any classification listed in the wage determination), be classified by the contractor so as to provide a reasonable relationship (i.e., appropriate level of skill comparison) between such unlisted classifications and the classifications listed in the wage determination (See 29 CFR 4.6(b)(2)(i)). Such conforming procedures shall be initiated by the contractor prior to the performance of contract work by such unlisted class(es) of employees (See 29 CFR 4.6(b)(2)(ii)). The Wage and Hour Division shall make a final determination of conformed classification, wage rate, and/or fringe benefits which shall be paid to all employees performing in the classification from the first day of work on which contract work is performed by them in the classification. Failure to pay such unlisted employees the compensation agreed upon by the interested parties and/or fully determined by the Wage and Hour Division retroactive to the date such class of employees commenced contract work shall be a violation of the Act and this contract. (See 29 CFR 4.6(b)(2)(v)). When multiple wage determinations are included in a contract, a separate SF-1444 should be prepared for each wage determination to which a class(es) is to be conformed.

The process for preparing a conformance request is as follows:

- 1) When preparing the bid, the contractor identifies the need for a conformed occupation(s) and computes a proposed rate(s).
- 2) After contract award, the contractor prepares a written report listing in order the proposed classification title(s), a Federal grade equivalency (FGE) for each proposed classification(s), job description(s), and rationale for proposed wage rate(s), including information regarding the agreement or disagreement of the authorized representative of the employees involved, or where there is no authorized representative, the employees themselves. This report should be submitted to the contracting officer no later than 30 days after such unlisted class(es) of employees performs any contract work.
- 3) The contracting officer reviews the proposed action and promptly submits a report of the action, together with the agency's recommendations and pertinent information including the position of the contractor and the employees, to the U.S. Department of Labor, Wage and Hour Division, for review (See 29 CFR 4.6(b)(2)(ii)).
- 4) Within 30 days of receipt, the Wage and Hour Division approves, modifies, or disapproves the action via transmittal to the agency contracting officer, or notifies the contracting officer that additional time will be required to process the request.
- 5) The contracting officer transmits the Wage and Hour Division's decision to the contractor.
- 6) Each affected employee shall be furnished by the contractor with a written copy of such determination or it shall be posted as a part of the wage determination (See 29 CFR 4.6(b)(2)(iii)).

Information required by the Regulations must be submitted on SF-1444 or bond paper.

When preparing a conformance request, the ""Service Contract Act Directory of Occupations"" should be used to compare job definitions to ensure that duties requested are not performed by a classification already listed in the wage determination. Remember, it is not the job title, but the required tasks that determine whether a class is included in an established wage determination.

Conformances may not be used to artificially split, combine, or subdivide classifications listed in the wage determination (See 29 CFR 4.152(c)(1))."
