### **Other Terms and Conditions:**

Security and Investigative Requirements: The employees of the contractor entering the institution may be required to meet certain security requirements prior to entering the institution. Primary concerns are the amount of contact that may occur between the contractor and his/her employees with the inmate population during the performance of the contract. Contractor employees are allowed access to the institution at the sole discretion of the Warden of the institution.

The program manager at FCI Safford is responsible for conducting the appropriate law enforcement check on all contractor staff that may need access inside the prison facility. By submitting a quote for service, the contractor and its employees agree to complete the required documents and undergo the listed procedure. An individual who does not pass the security clearance will be unable to enter the BOP facility. Any individual employed by the contractor who is deemed not suitable by the BOP requirements will not be granted access to perform services under the contract. This is a condition of the contract. Finally, the contractor shall be in compliance with 8 CFR 274a regarding employment of aliens.

Service Contract Labor Standards Wage Determination: The applicable wage determination for this requirement is WD 2015-5481 a copy of which is available at [www.sam.gov](http://www.sam.gov) or upon written request from the Contracting Officer. Services rendered under this agreement are subject to the version of the Wage Determination that is current at the time of award acceptance.

**Evaluation of Quotes:** In addition to the pricing competition conducted via reverse auction procedure, quotes will also be evaluated considering technical capability (product offered), delivery turnaround, and past performance. An offer of award will be made to the responsible quoters who quote, conforming to the solicitation, is deemed to be the most advantageous to the Government considering these factors.

**Quote Submission Instructions:** All quotes submitted must include the following information:

1. Quotes shall identify the brand of equipment to be supplied. If different from the UNIMAC model identified in specifications, the quote shall describe how alternative product offering meets or exceeds the salient characteristics identified in the RFQ Attachment 1 to include product specifications, brochures, manufacturer spec sheets.
2. Contractor's quoted price shall be fully burdened fixed price to fulfill FCI Safford's requirement for supply/install of new washer and removal/disposal of existing equipment (i.e., equipment, labor, profit, overhead, taxes, shipping, etc.).
3. Quotes shall state expected delivery turn-around from award to supply and include a preliminary installation schedule.
4. Contractor should provide point of contact information for three professional references for which similar work and has been completed. Contact information should include: Name of Reference, phone, email, fax, and type of work performed.
5. Quotes shall include discount terms for prompt payment – if any.
