MEMORANDUM FOR MICC-Fort Drum

SUBJECT: Brand Name Exact Match Memo for Unison Buy [#]

1. In accordance with AR 220-90: "First-line, professional-quality musical instruments are required in Army bands. Responsible supporting procurement activities will procure items based on the recommendation of the Army band officer, warrant officer bandmaster, or in the absence of either, the band senior sergeant (see para 1-4j(2)). Any disagreement between the above personnel and a procurement official over what constitutes "first-line, professional-quality" musical instruments, electronic equipment, or musical support equipment will be referred to the command's SBO or to CAB, as appropriate, for determination". In this case the officer bandmaster has determined that these models are a best fit for the current mission requirements of the United States Military Academy Band. These items are a lifecycle replacement item.

2. The primary research is the firsthand accounts and experiences of our organizations subject matter experts and members' proven successful use of said products in mission related context. Substitute items would be of inferior or unproven quality pertaining to mission needs.

3. The quality of these brands have consistently been shown to survive to the designated life cycle and beyond for this type of equipment. Therefore, it is the only brand that can reliably fulfill the government purchase requirement in this case 2.
