**Description of Requirement**

*Kootenai National Forest has a requirement for a total of 33 accessible expanded steel picnic tables that meet Forest Service Accessibility Standards. Supply and deliver prefabricated expanded steel tables along with drive-in-ground anchors.*

*Technical Specifications:*

- 8' long expanded steel top with thermoplastic covering.
- One-piece welded construction of the table frames and supports from steel 3"x6" rectangular (1/8" wall thickness) and 2 1/2" square tubing (1/8" wall thickness).
- Wheelchair accessible at both ends of the table with compliant toe/knee clearance.
- Provides ability to anchor table to the ground with the use of dive-in ground anchors and drive rods.
- All steel components are hot-dip galvanized after fabrication to provide corrosion resistance. Has a uniform zinc coverage of at least 2 oz. per square foot.
- D-type tabletop construction with seats created with one-piece welded construction, fabricated from 3/4" #9 expanded steel with 2" roll formed 14 ga. steel edges.

- *Thermo-plastic coating which is UV-stabilized for durability, heat-fused and bonded to the steel. Polyethylene finish that is impact and mold resistant.*
- *Available in unobtrusive brown color to blend into the forested environment.*
- *Non-trip, walkthrough design.*

- *Extended top design that does not allow for full seating with or without wheelchair present.*
- *Brightly colored tables that stand out in the campground environment.*
- *Lightweight construction that will not hold up to years of use*
- *An anchoring system that requires a concrete pad.*
